**From the January Council Meeting:** GK Kenny Svrcek and members enjoyed a meal of pork steaks, baked potatoes, green beans by Lambert Skubal, Jr, and his helpers, for dessert chocolate chip pan cookies by Debbie Konarik. GK Kenny Svrcek's meeting reviewed Calendar for the remainder of January and upcoming February. Law Enforcement/First Responders Chili Supper on Monday, February 5<sup>th</sup> and St. Joseph's Parish Fundraiser/Raffle Drawing & BBQ Chicken Dinner on Feb. 11, Lent Fish Fry Friday's, our major fundraiser also in February and March. The RVFD Fundraiser is scheduled for April 20. Treasurer Lambert Skubal had a surprise for the council: Our KC Hall building insurance bill was received and last year was \$7242 and this year \$12,351.

- **COUNCIL 7014 EXPENSES** for January include TXU outside (parking lot) security lighting \$83.43, Electric bill: APG&E \$515.31, SWMWSC water \$115.53, Dillo Disposal \$200.38, BBQ Advertising KRXT \$50, Comptroller Sales Tax \$471.21, Donations: \$200 St. Joseph's Church monthly tithe, TX State Charities \$455 (\$455+\$435 contributed by 4 members =\$890 total goal for 2023). Memorial Donations received: \$500 Chad Barcak, \$100 Paul Voelkel. Christmas Party Donation \$180.

- SPECIAL MEETING CALLED for the council to have a serious discussion of mounting expenses following the insurance rate increase referred to above. Members met on Jan. 25 at 6:30pm. The KC Hall is important to the community and to the council. Some ideas explored were: more KC fundraisers, get the more lucrative rentals back by accommodating their desired event timetables, restructuring/consolidating the KC work crews, eliminate (most/all) rent freebies, look into possibly selling some of the unused acreage behind the KC hall.
