

State Per Capita is an assessment and payment, required per Article V, Sections 1 and 2 of the Texas State Council Bylaws. State Per Capita is used to fund the operation of the Texas State Council.

As of January 21, 2023, we have had 617 councils that have paid in full their state per capita. Congratulations to the Victoria Diocese for having 100% of their councils paid in full. Tyler Diocese is at 96.88%. We have 25 councils that have made a partial payment and 112 that have made no payment at all.

Those councils that still owe their assessment will be receiving their 2nd assessment notice which is due on or before March 1, 2023. Delinquent councils or their representatives are ineligible to participate in state sponsored activities and/or events such as seating delegates at the state convention, state athletic events such as softball, bowling and golf, state youth free-throw and educational scholarships, etc. Please make your checks payable to "Texas State Council" and mail them to the State Office. Please put "State Per Capita" in the Memo section of your check.

Star Council Awards

As we head into Lent, this is a great time to focus your council's activities on the Faith activities of the Faith in Action programs. At this time of year, many men in your parishes are refocusing their relationship with Jesus Christ. Now is a great time to give these men the opportunity to deepen their faith through the Knights. Following are some ideas of programs you may want to try.

Consider hosting a Holy Hour in your parish. We should encourage deep personal encounters with Christ through Eucharistic adoration in the form of Holy Hours and Eucharistic Processions. As Catholics, we believe in the Real Presence: that Jesus Christ is truly present — body, blood, soul, and divinity — in the Eucharist. As such, we are compelled to grow in our devotion to Jesus in the Eucharist and to share His presence with the world.

Also consider hosting one of your parish Stations of the Cross. Your pastor may welcome parish groups putting on the Stations – many great versions can be found online. This will raise the visibility of your council and give your members a chance to deepen their faith.

The "Into the Breach" program provides a wealth of videos that members of your parish will gain from. Many councils have one video they watch, then get together and have a group discussion about it. This can be done in person or virtually. Advertising this in your parish may draw in men who are looking for a faith program which they can do on their own time.

You still owe the 1st assessment; it was not waived. If you have already paid, thank you. Supreme Per Capita is due by April 10, 2023. State Per Capita is due by March 1, 2023.
